#### IN THE BEGINNING

This is the 22<sup>nd</sup> year that the Alamo City Rivermen has done this event, which has always been one of our most popular trips. The Freze Trip was the very first trip for the club when it was formed in 1987, and it just keeps on going and going.

#### **BURN BAN**

Because of the burn ban in Bastrop County, we have moved the event to the Lake Wood Recreational Area in Gonzales County, which is run by the Guadalupe-Blanco River Authority. But Gonzales County also has a burn ban, so all fires must be elevated. That includes fire pans and chimney stacks. Putting them on cinder blocks or metal dutch-oven tables would work. Please bring what you have to help. We'll stack dutch ovens and cook in the campsite's fire ring. We'll try for the site in the center section that has the two concrete picnic tables. If you have a garden hose, bring it so we can run water from a faucet to the cooking area.

# LOGISTICAL PLANNING REQUIRES COMMITMENT

We have to reserve campsites and buy food for 50 to 60 people for community meals. If you're going to participate, you must commit. No half-hearted "well maybe," or "I'm thinking about it". The rule is a GO or NO GO kind of trip, sort of like YES/NO, ONE/ZERO AND ON/OFF.

# **HOT WINE GROG (OPTIONAL)**

#### **FEE SCHEDULE**

Day Use

Day Use Fee: \$7.00 per vehicle per day. Paid for all vehicles entering the park.

Maximum occupancy number per vehicle is six (6) persons.

**Individual Day** 

**Use Fee:** \$2.00 per person per day for ages 6 and over. Individual fee is charged

for pedestrians, motorcycles, bicyclists, commercial bus passengers, and groups exceeding six (6) persons per vehicle. Children 5 years old and

younger are free.

Annual GBRA Vehicle Permit:

\$115.00 each vehicle. Paid in lieu of the Lake Wood Day Use Fee. Only

covers entrance for six (6) persons per vehicle. At times portions of the park will be closed to the public due to special events, maintenance, safety reasons, or flood conditions and annual permits do not allow

entrance during these times.

Camping All camping fees paid Check in after 8 AM

instead of Entrance Fees Check out - Mon - Sat. by 2 PM

Sun. & Holidays Check out by 5 PM

RVs, Trailers, Campers

& Pop-Ups: \$23.00 per vehicle per camping day. Vehicles using 50 AMP service are

charged \$26.00 per day.

**Tents:** \$20.00 per vehicle per camping day for campsite.

**2<sup>nd</sup> Vehicle:** \$8.00 per additional vehicle per camping day for each 2<sup>nd</sup> vehicle at

campsites including visitors.

**Weekly Rate: 15-30 Amp** \$112.00 per week Oct. 1 - March 31; \$133.00 per week April

1 - Sept. 30.

Monthly Rate: 15-30 Amp \$360.00 per 30 nights Oct. 1 - March 31; \$450.00 per 30

nights April 1 - Sept. 30.

**50 AMP Service: 50 AMP** service is 147.00 per week year-round or \$510.00 per 30 nights

## IMPORTANT POLICIES FOR PUBLIC USE

## SAFETY ON THE WATER

Swimming, Boating, Skiing, and all other activities are done at the visitor's sole risk. In case of emergency, notify park headquarters immediately.

Please be aware of submerged stumps and logs in the lake and additional Guadalupe River laws.

Visitors are expected to observe all usual land and water safety precautions and rules.

Please be aware of dangerous currents and steep drop offs around and downstream of the dam.

Watercraft shall not operate within 200 ft. of the H5 Dam.

Please observe the "NO WAKE" zone around the dock and canal.

Violation of any regulation or conduct that interferes with the enjoyment of other visitors will not be tolerated and may result in the removal of offending parties from the park.

#### CAMPING AND PICNICKING

ALL VEHICLES ENTERING THE PARK MUST PURCHASE A PERMIT. A night deposit box and instructions are located at the front of office. **Speed limit on park roads is 10 mph.** All motor vehicles must operate on designated roads. Off-road vehicles are not allowed within the park. No vehicles may drive down the river banks.

There is a maximum limit of eight (8) people per campsite and two (2) camping units per campsite, except for RV's, Trailers, and Pop-Ups. No vehicles are allowed on or around the Dam Levee.

Persons under 18 years of age desiring to camp overnight must be accompanied by a parent or legal guardian or be supervised by a responsible adult.

Quiet hours are between 10:00 p.m. and 7:00 a.m. and unnecessary noise or activities are prohibited to allow campers a good nights rest. Please use common courtesy.

GROUND FIRES ARE NOT ALLOWED. Fires are allowed only in furnished grills and pits.


The boat ramp is open 24 hours a day. (Please remember quiet hours must be observed)

Picnicking, visiting, and driving through are available only between 8:00 a.m. and 10:00 p.m.

NO PETS ARE ALLOWED unless they are on a leash or confined in a vehicle.

NO GLASS CONTAINERS are allowed in the park.

To preserve and protect park vegetation and animals and their habitat, the possession, use or discharge of firearms, archery equipment or fireworks are prohibited.
